- Entries will be accepted on the basis of date received.
- Entries **must** be submitted on the forms or copies of the forms supplied in this premium.
- Please include your e-mail address on entry forms to receive confirmation of pre-entries. Confirmation of entry will be made after the pre-entry closing date.
- Run order will be drawn at close of entries on day of trial.
- Bitches in heat will run in order.
- **NO** refunds after close of entries, unless your run is sold to someone on the wait list.

## General Information:

- Insufficient funds will result in a \$50.00 fee. Entrants who stop payment will be placed on a cash-only basis with High Plains ASC. Entrants will have five (5) days to make good on any insufficient funds with a money order, cashier check or cash. Failure to make good on insufficient funds will result in your entry being marked invalid and all awards, points, earned at this trial will be withheld.
- The Course Director, members of High Plains ASC and the owners of the host facility assume no responsibility for any loss, damage or injury sustained by any exhibitor, handler, dog, property, child or spectator. This jackpot trial is being held on private property. You understand by your attendance and/or entry that the Show/Trial Committee have the right to refuse or excuse any entry for good cause. Good cause would be any violation of High Plains ASC rules.
- Entry fees will not be returned if the show cannot be opened or be completed due to riots, civil disturbances, acts of God, public emergencies or other events beyond the control of High Plains ASC. Entry fees will not be refunded if the dog is absent, disqualified, excused or barred from competition by the Course Director or the Judge.
- It is distinctly understood that every dog entered in these trials is in the care, custody and control of his/her owner or handler during the entire time the dog is on the trial premises. Please take responsibility for your dogs and children. Any exhibitor whose dogs or children create unnecessary disturbances or repeatedly engage in unsafe or disruptive behavior may, at the discretion of the Trial Committee or HPASC, be asked to leave the trial site. There will be no refunds for entries if a dog or handler is dismissed from competition for any reason.
- Only dogs entered in the trial will be permitted on the trial premises. When not in the arena, ALL dogs must either be crated, in escape proof x-pens or on lead and under control at all times.
- All Exhibitors **MUST** pickup after their dog and setup.
- Exhibitor agrees by participation to pay replacement cost or vet fee, as applicable, for injury or death of an animal. Replacement per sheep is \$250.00.
- Notice that Exhibitors through submission of entries, acknowledge that they are knowledgeable of, and agree to follow High Plains ASC Trial Regulations and Policies, listed in this premium.
- Safety shall always be the foremost consideration in actions by handlers at all times.
- Participation is a privilege afforded by High Plains ASC and may be extended or withdrawn by the host club's trial committee based on suitable cause only.

## Jackpot Trial Series Rules:

- The Jackpot Trial Series will consist of 4 trials.
- Finals Trial: Exhibitor(s) must enter in all three previous trials to be eligible to enter in the Finals Trial.
- Exhibitors must start and finish the Jackpot Trial Series with the same dog in the same class.
- All breed dogs are eligible to compete in the trials.
- Limit of 40 runs per trial.
- Attention Exhibitors: Only dogs entered in the trial will be allowed on the trial grounds, except for dogs working in the stock pens. This is for your safety and protection as well as a courtesy to the host facility.

## Awards & Trophies:

- **Payout per Trial:** After completion of each trial, the trial secretary shall make payment to winning contestants in the Beginner/Novice class and Intermediate/Advanced class. Computation of payout for the winning contestants will be determined based on number of entries received, judges fees, stock fees and other trial expenses.
- **Finals Trial Award:** In addition to payout for the Beginner/Novice and Intermediate/Advanced classes a Silver Belt Buckle will be awarded to the Finals Trial winner of the Beginner/Novice Class and the Finals Trial winner of the Intermediate/Advanced Class.
- No ribbons or any other trophies will be awarded at any of the trials.

## Course Trial Rules:

- All unnecessary gripping, harassment and mishandling of livestock will be a disqualification to be determined by the judge.
- Time will start when handler sends the dog on the outrun.
- All sheep must complete all obstacles and handling chores to receive a qualifying score.
- Handler must have all latches, gates and doors closed before advancing to next obstacle.
- Beginner/Novice handlers may not cross the 20' beginner/novice foul line. If handler crosses foul line, it will be considered a disqualification.
- Intermediate/Advanced handlers may not cross the 40' intermediate/advanced foul line. If handler crosses foul line, it will be considered a disqualification.
- 4 head of sheep will be used per run for all classes.
- Beginner/Novice runs will be 10 minutes with time warnings at 5 minutes and 2 minutes.
- Intermediate/Advanced runs will be 8 minutes with time warnings at 5 minutes and 2 minutes.
- Courses will be posted at each host facility the day of each trial and will be modified to fit the individual facility.
- All decisions by the judge will be considered final.
